1. This Privacy Policy

1.1 The Independent Financial Adviser ("CRYSTAL WEALTH MANAGEMENT") referred to in the Contact section of this Web Site, is committed to protecting your personal information and other data provided to CRYSTAL WEALTH MANAGEMENT via this and any other CRYSTAL WEALTH MANAGEMENT web site ("Web Site").
